MINUTES

Committee meeting held via video conferencing due to Covid-19 restrictions on travel/social-distancing Monday, 30 March 2020, at 7:30pm

Minutes of Last Meeting: Approved and adopted. All minutes dating from 2012 are now uploaded on the club's website in a non-public location. Future minutes will be similarly uploaded.

Captain and Juniors Report (attached) – No matters arising

Other Squad Reports – as the club has been closed since 17th March, no reports were requested from the squad coordinators.

Boathouse Management Committee Issues: The financial implication of the site closure and potential arrangements to be agreed with our tenants are outlined in an attached document titled 'Notes About the Lockdown Budget – Worst Case'.

Because the closure of the site was sudden, the fridge has likely not been cleared out and unplugged. Antony will gingerly attempt to do this on his next site visit. He will also open as many boat hatch covers as he can manage.

Welfare: Carol reported that no guidance from British Rowing has been forthcoming to CWOs regarding the Covid-19 outbreak.

It was suggested (in a WAGS meeting) that the BR Code of Conduct should be included in all membership packs. We agreed this should be done. Clair to arrange this for any beginners she enrols, however Patsy and Steve will need to develop a process for doing the same for new members who bypass the LTR programme. It is important that people new to the club, however they arrive, are given at the very least a copy of the Code of Conduct.

Safety: Report attached.

Events:

<u>BAR</u> – Geoff Peattie and Julian had kept this under review as Government and BR policy evolved. It was now clear that the regatta had to be cancelled. The Committee agreed.

Jon queried whether the regatta could be rescheduled to late August, for example. Penny said most of our competitors are schools, who (hopefully) will be gearing up for a new school year. All agreed it wouldn't be feasible.

There was discussion amongst local clubs recently about holding an informal time trial cum regatta at Saltford when we are able to row again. This met with unanimous agreement from the committee. The overarching theme will be getting everyone back on the water, and encouraging everyone – regardless of experience – to have a go. Other local clubs have offered to help organise and run so AVN would not have to provide all the helpers.

<u>ASH</u> — cancelled due to unsafe weather conditions. Estimated loss of £350-400, assuming the loo hire company allows us to defer the booking to the next event we can run. It was already deferred to BAR, so Jon will now ask them to defer to either Bluefriars or Avon Autumn. If they can't do this, it would add £300 to the estimated loss.

AAH – still no Race Manager or Personnel Manager.

<u>BLUEFRIARS</u> – Antony spoke to Simon Brown (MNK coach) before the shutdown. Simon indicated that they are unlikely to continue running their October small boats head. Simon committed to letting us know the final decision as soon as it is made. Antony also asked him to let us know before any communications with BR, to which Simon also agreed.

NON-ROWING EVENTS — The women's squad is busy trying to stay in shape during the nation-wide lockdown. There are a number of initiatives in their infancy at the moment. Please can those people involved in organising things send Penny the details so she can circulate it to the whole club via Rowing Notices.

Finance (report attached): The 'lockdown' budget prepared by Julian and Anthony was the main topic of discussion. The budget and relevant notes are attached. The club is financially robust enough to withstand the worst-case scenario for the next financial year (ending March 2021), which is as far as the projection has been done.

The Boathouse Management Group will soon set the level of contributions to be required from the Club in the forthcoming financial year. With the site closed, there would be a case for a reduction, but the Group is being recommended to keep the contributions unchanged until August when there would be a review. A main driver of this was the undesirability of any disturbance to the existing mechanisms for the timely payment by the parties of their contributions.

Canoe Avon have asked about the impact of the site closure on the fee they pay the Club. Julian explained that their fee broadly covers their share of the Club's contribution to Boathouse Management, based on the space they occupy. The Committee agreed that any reduction in the Boathouse Management charge should be reflected in the Canoe Avon fee. Julian will draft a response explaining the situation and checking whether paying the normal fee initially would cause them difficulties, and circulate it to the committee before sending. We do not want to see the canoe club fold so will be as helpful as we can during the crisis.

Empire Dragon Boats have not been in touch. And the mooring income we have, via Saltford Marina, is guaranteed regardless of whether the moorings are occupied or not.

Julian will advise our insurers that the boats are currently not in use, in case this affects our coverage and/or premiums.

Subs (report attached): There have been 20 GoCardless requests for a subs holiday. Until the bank statement for March is received we won't know how many members who still pay by standing order have taken a subs holiday. People have been quite tentative about asking for the holiday and the committee agreed that we should communicate (via Rowing Notices) that the club is in a robust financial position to weather the next year, and that if anyone needs to stop their subs they only need to ask – and not feel guilty! Philippa will draft a message and send to Penny for circulation.

Admission of New Members: none

Any Other Business:

<u>Philippa</u> — Has been the beneficiary of several boxes of club records from Robin Leach. She is currently going through them and will, in the fullness of time, bring the relevant documents to the club to add to the archive material Keith Trivett has placed in the eaves upstairs.

<u>Jim</u> - Jim, Jon and Antony were working on a floodgate for the facilities block front door. The as yet unfinished project and materials are in the lobby behind the door. Don't move them please.

Antony – Advised that the Rowing Foundation have grants available (for juniors) so we should apply.

Covid-19

On 17/03/20 the following was emailed to the club membership

CORONAVIRUS PRECAUTIONS:

In line with government guidance issued this afternoon, we are cancelling all rowing, gym-related, circuit training activities – as well as social gatherings/meetings - at the club until further notice.

The message from the experts is clear: avoid unnecessary travel and observe social distancing protocols. Rowing is a sport that puts people in close proximity to each other before, during and after an outing. The risk of inadvertently spreading the virus is significantly increased in these circumstances.

Club boats and equipment are NOT to be used during the closure – including club singles.

If you wish a payment holiday from your subs during this time, please let Philippa (philippa.sondheimer@gmail.com) know so she can make the necessary adjustments to her records. Whilst we would all prefer to be on the water, we must act responsibly to protect us all.

NOTES ABOUT THE LOCKDOWN BUDGET WORST CASE

I thought it would be useful to put some simple numbers together to help the Committee assess the impact of the coronacrisis on the Club's finances.

The attached is a worst case scenario. It is very simple, and should provide a platform for simple calculations of the effect of things turning out better.

It covers the year to March 2021 and assumes:

- no rowing for the whole year
- no subs income (but BR waive most of the affiliation fee) (see Note 1 below)
- no Boathouse Management rebate (see Note 2 below)
- unchanged income from Canoe Avon, dragons, moorings (line "Subscriptions and rent from associated clubs") (see Notes 3, 4,5 below)

The comparative figures for the year to March 2019 are included (2020 not yet available: probably like 2019 apart from the lack of £7,000 due to the cancellation of the 2020 Spring Head).

The figures suggest an accounting loss under these worst case assumptions of around £30,000. This compares to a profit of some £20,000 in the year to March 2019. In terms of the Club's cash, the cash drain over the year would be about £10,000 (since depreciation is not a cash outlay). The Club's cash balance is currently around £80,000, so the Club can withstand such a cash drain.

NOTES

- 1. <u>Subs</u>: the subs reduction is unlikely to be nearly as bad as the worst case. So far about 20 people (mostly adults) have requested a subs holiday, reducing subs by about 6,000, though requests are still coming in. Non-payment by Bath Spa will reduce subs by a further 2,500.
- 2. <u>Boathouse Management fees</u>: the normal fee is 885 per month (10,620 per year, see line "Rent and maintenance of premises"). The Boathouse Management Group will shortly discuss its budget for the year. The proposal being put to it is that fees should be maintained at the normal level until August, when the position will be reviewed. At that stage, there may be an adjustment. There has been a review of what costs will be avoided under closedown, and it looks as though the parties' fees could be reduced by about 40% without failing to cover unavoidable costs.
 - An element of the costs is the Duchy rent. The potential for rent reduction/deferral will be explored with the Duchy.
- 3. <u>Canoe Avon</u>: Canoe Avon have written to ask whether ACRC will consider a reduction on their subs for the period of closure. They currently pay us £1,668 per year. This more or less covers the proportion of the Boathouse Management fee attributable to their space. The Club proposes to ask them to pay their normal amount for April to September, but to explain the situation regarding Boathouse Management and to hold out the possibility of a reduction/rebate if the Boathouse contributions are then reduced.
- <u>Dragons</u>: the Dragons pay us £1,500 per year to rent part of the West Wing, which is outside the Boathouse Management responsibility. It is suggested that the Club waits to see if any approach comes about a reduction.
- Moorers: the mooring income is £1,600 per year. Under our deal with the Marina this should not be affected.
